### German Social Cohesion Panel

Established in 2021, the German Social Cohesion Panel (SCP) is a wide-ranging representative longitudinal study of private households in Germany, carried out in collaboration of the Research Institute Social Cohesion (RISC) and the German Socio-Economic Panel (SOEP).

The aim of the SCP Documentation is to thoroughly document the survey's data collection and data processing.

## 1 General Information

The PBRUTTO dataset contains information about the individuals in the gross sample which is not asked in the individual questionnaire but is instead background information from the sampling frame or survey fieldwork. Variables that only contain information from the residents' registration offices have the suffix “\_reg”. The information from the residents' registration offices may differ from the survey data.

In some places in the documentation and in the data, year numbers are used, for example, for the names of variables and of the questionnaire instrument. These year numbers are always based on the field start of the data collection of the corresponding survey wave.

Data in this dataset may be missing due to different reasons. Missings are coded “[1] No answer” if the registration office fails to provide valid information that is required for the variable. Missings are coded “[2] Does not apply” if the information is missing due to the study design. Information from the residents' registration offices is only available for the initial anchor persons.

This identifier groups individuals into their original households at the start of the panel. That means that a person's CID is time-constant and will always relate them back to the household they initially belonged to, even if they moved out since.

Anchor persons (AP) are respondents at the time of recruitment who were drawn as part of the initial random sample at the residents' registration offices and invited to take part in the survey. In addition to the personal questionnaire, these people usually also complete the household questionnaire. Household members (HM) are respondents who were specified by anchor persons as living in the same household aged 18 and over and were also invited to take part in the survey. HM only complete the personal questionnaire. New household members (NHM) are respondents who were additionally named as household members by anchors from wave 2 onwards. In particular, this includes people who moved into the household or who have reached the age of 18 in the period since the last survey. These persons receive an extended personal questionnaire and, with their consent, are integrated into the panel as HM from the following wave onwards.

If HM or NHM leave the household after inclusion in the panel, these individuals themselves become the AP of the new household in the following wave, unless this role is filled by another member of the household. Similarly, a HM or NHM becomes the new AP if the original AP leaves the household or refuses further interviews.
